A draft declaration had been co-edited in 1998 with UNESCO, with its article-by-article commentary. The current version is presented as a text from "civil society", improved thanks to the work of many observers from various continents, gathered in the Observatory of Diversity and Cultural Rights, linked to the International Organization of La Francophonie and UNESCO.” (website)</p>
